

Eighth Avenue Demolition Completed Demolition is Ongoing on Sixth Street and Soon to Begin on Fifth

The City's Department of Buildings recently signed off on the demolition of the Hospital's buildings on Eighth Avenue, thereby signaling the official completion of that phase of the project.

The Hospital is especially proud that, during the entire period of demolition, there were no community complaints regarding dust, noise or other inconveniences arising from the work on Eighth Avenue.

Demolition work is currently focused on Sixth Street. Periodic construction deliveries will continue. Abatement activities necessary to prepare for demolition on Fifth Street are also ongoing.

The work hours continue to be Monday through Friday, 7:00 a.m. to 3:30 p.m. We do

not anticipate extended work hours or weekend hours but will inform the community should this change.

The anticipated schedule for the next month follows:

May 16th—May 20th

- Demolition of Sixth Street buildings to continue.
- Fifth Street water and sewer service to be disconnected.
- Scaffold installation to begin on Fifth Street.

May 23rd—May 27th

- Demolition of Sixth Street buildings to continue.
- Scaffold installation on Fifth Street to continue.

- Scaffold installation on Fifth Street to continue.

June 6th—June 10th

- Demolition of Sixth Street buildings to continue
- Scaffold installation on Fifth Street to be completed.
- Abatement of Sixth Street buildings to be completed.

June 13th—June 17th

- Demolition of Sixth Street buildings to be completed.
- Removal of sidewalk shed on Sixth Street.
