Steel Installation is Ongoing



Steel installation is ongoing and both of the tower cranes are operational. As we have shared previously, the arrival of the second crane was delayed due to revisions of the Department of Buildings (DOB) tower crane protocols. The team is working to "close the gap" between the East and the West framing. The logistics on Sixth Street will continue to be implemented and will continue to be extended as needed to accommodate this phase of the project.

The installation of the personnel hoist and the Sixth Street construction loading dock has been completed. The hoist will be further installed up the building as the steel structure is completed.

The schedule for installation of electrical service by Con Edison is still to be determined. Notice will be sent out when this information is shared by Con Edison, as this is not in Lendlease's control.

The Sixth Street trench and sewer work commenced on Monday, May 14. A driving lane for traffic, as well as a pedestrian walkway, will be maintained during this work to mitigate impact. The Carrington driveway will be closed to facilitate this work.

Work for the construction of the new CCH Loading Dock on Fifth Street has commenced. Reinforcement of the underside is to be

scheduled and will impact parking in the garage. Notice will be distributed when the schedule for this work is confirmed.

Upcoming Work

The current construction work hours are Monday through Friday, from 7:00 a.m. until 6:00 p.m.

When there is a need to make up for delays due to weather or other unforeseen circumstances, work is done between 9 a.m. and 5 p.m. on Saturdays. Separate notifications for weekend work will be distributed when necessary with the description of work activities.
